

## **GDPR CLAUSE III INTERNATIONAL SCIENTIFIC CONFERENCE**

According to Art. 13 sec. 1 and sec. 2 of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (GDPR), I inform you that :

1. The administrator of personal data of participants of the 3rd International Scientific Conference, entitled "New technologies in medicine - Interdisciplinary patient care" is the Warsaw Medical Academy in Warsaw with its registered office at Rydygiera street 8, 01-793 Warsaw, Didactic and Scientific Center, Faculty of Medical and Social Sciences, Okopowa street 59, 01-043 Warsaw. 2. Personal data will be processed on the basis of the consent of the participant of the 3rd International Scientific Conference.
3. The Warsaw Medical Academy in Warsaw processes personal data for the purpose of organizing and conducting the 3rd International Scientific Conference, publishing a post-conference publication, in order to fulfill tax and accounting obligations, as well as for marketing and archival purposes.
4. Providing personal data by the Conference participant is voluntary, but necessary to participate in the Conference.
5. Personal data will be stored for the period necessary to achieve the above-mentioned purposes.
6. The data will not be made available to third parties, except for cases provided for by law or when the University entrusts third parties with the processing of such data.
7. Conference participants have the right to access personal data, the right to request rectification of their data, the right to request deletion of their data, limit the processing of their personal data, as well as the right to object to data processing, the right to transfer data and the right to withdraw data at any time consent to their processing.
8. Withdrawal of consent will not affect the lawfulness of processing based on consent before its withdrawal.
9. The Conference participant has the right to lodge a complaint with the President of the Office for Personal Data Protection against unlawful processing of personal data.
10. Personal data will not be subject to decisions based solely on automated processing, including profiling.
